

Minutes of the Regular Meeting and Public Hearing of the Board of Trustees of the Village of Lake George, NY, held on Monday, August 19, 2024 at 4:30 p.m. Zoom teleconferencing was available for audio only.

Mayor Perry asked Trustee Root to lead the Pledge of Allegiance.

At 4:32 p.m. Mayor Perry opened the Regular Meeting and Public Hearings for Proposed Local Law 5, 2024, Chapter 182, Street Performers and Entertainers and Proposed Local Law 6, 2024, Chapter 135, Licenses and Permits. The Public Hearings were left open.

Mayor Perry presented the minutes from the Regular Meeting held on August 19, 2024. Trustee Root made a motion, seconded by Trustee Miller, carried by a majority to approve the minutes from the Regular Meeting held August 19, 2024.

#### **MOTION PASSED**

At 4:40 p.m. Trustee Mastrodomenico arrived.

Monthly reports from the Sanitation Department and Caldwell Sewer District, Superintendent of Public Works, Fire Department, REC Center, and Director of Events were presented and made available to the public.

Mayor Perry asked Tim Cianciolo of Craft Producers who was available on Zoom, to please present his request to the Village Board.

Mr. Cianciolo said that he recently had an event at Wood Park that overlapped with a not-for-profit event that was occurring at Shepard Park. He said that due to that double booking, and the extremely hot weather, the show had poor attendance. Mr. Cianciolo said that he would like to find a resolution to help offset the loss to his vendors. He asked that the Village Board consider refunding all his vendors the \$50 fee that they had paid for vendor permits. He also asked that the Village Board refund the fees for use of Wood Park.

Mayor Perry responded that the Wood Park fees are paid to the County and that the Village Board cannot refund that money. He then said that the double booking was due to Mr. Cianciolo changing the date of his event after the other event had already been booked. Mr. Cianciolo responded that he did not know of the other booking and would not have changed his event to that date had he known. He said that he had not been informed of a double booking by the prior secretary to the Mayor. Mayor Perry asked approximately how many vendor permits were

issued to which Mr. Cianciolo responded one hundred. Mayor Perry said that the Village would not refund \$5,000.

Trustee Filomeno said that the Village could not control the weather, and that refunding \$5,000. was not feasible. Mr. Cianciolo said that he should have been told of the double booking. Trustee Root said that part of the problem was that the person who helped book it was no longer employed with the Village. Trustee Miller said that Mr. Cianciolo made a good point, and that the website should reflect all upcoming events and dates. Mayor Perry said that the two events are completely different kinds of events, and that he believed that the events would draw completely different people. Mr. Cianciolo said that his customers were upset by the Village allowing both events at the same time. Trustee Root suggested that perhaps the Village could offer a discount on fees next year or possibly allow more Occ Tax. Tim Cianciolo said that he could accept that offer.

Mayor Perry then introduced a new proposed Local Law amending Chapter 177, Special Event Parking and Highway closure. In the proposed amendment, there is wording added that would prohibit residential parking for a fee except for four specifically designated events. The events where it would be allowed would be during Americade, July 4<sup>th</sup>, Nationals Car Show, and during Thursday fireworks. Mayor Perry asked that all Trustees read over the proposed Local Law amendment and bring forth any questions or suggestions before the next Board Meeting.

Mayor Perry presented employee hires and pay for consideration.

**§ 182-3 Application for license; fee.**

- A. Application for such licenses shall be made upon a blank form furnished by the Mayor, signed and verified, giving the name, address and telephone number of the applicant. Said application shall be filed with the Village of Lake George offices and accompanied by a fee ~~[of \$75]~~.
- B. Applicants may be required to perform their chosen skills at a time and place so designated by the Mayor in advance of each season.

**§ 182-7 Locations and hours for performances.**

- A. Performances regulated hereunder will take place in the following areas only:

  - (2) Lower Montcalm and Canada Street; and
  - (3) Canada Street at the U.S. Post Office.
- B. Performances may also take place at a fair or public festival authorized by Village law and upon written permission of the sponsor therein.
- C. Performance hours shall be approved by the Mayor. ~~[Performances shall be restricted to the following: 6:00 p.m. to 10:00 p.m. on Thursdays, Saturdays and Sundays only.]~~

ARTICLE II. LICENSES FOR SPECIAL EVENTS**

**Be it enacted** by the Board of Trustees of the Village of Lake George ("Village"), County of Warren, State of New York ("State") as follows:

**§ 135-12 Application for transient vendor permits.**

- A. Applications for a transient vendor permit may be obtained from the Village Clerk after a special event permit has been issued.
- B. Applications for a transient vendor permit will require applicants to provide satisfactory information, including but not limited to the applicant's name, address and telephone number, sales tax number, the name, date and location of the special event and the goods or services to be sold by the transient vendor.
- C. All applications for a transient vendor permit must be signed by the applicant, the holder of the special event permit and the owner or legal representative of the real property on which the special event (central or satellite location) will be held.
- ~~D. Applications must be filed with the Village Clerk not less than 30 days prior to the start of the special event.]~~
- D. ~~[E.]~~ All applications for transient vendor permits must be accompanied by a nonrefundable fee ~~[of \$50]~~, to be remitted by the special event licensee. [Amended 1-10-2005 by L.L. No. 1-2005]
- E. ~~[F.]~~ The Village Board shall decide, based upon the information set forth in the application, whether ~~[an]~~ a special event application is complete and whether or not it will be approved. The Mayor, if necessary, may require the applicant to provide additional, relevant information or documentation.
- F. ~~[G.]~~ All complete special event applications must be approved or disapproved by the Village Board within 30 days of the filing with the Village Clerk.
- G. ~~[H.]~~ An applicant whose application to the Village Board has been denied may, within 30 days of such denial, file an appeal pursuant to Article 78 of the Civil Practice Law and Rules.

Mr. Heroux explained that he had a Food Truck called All Fired Up Barbecue, and that at the Kelly's Angels event, a Village employee inadvertently plugged his 110 Volt equipment into a 230 Volt outlet. It damaged his sandwich/salad top refrigerator and refrigerator merchandiser. He asked that the Village reimburse him for the cost of a both pieces of equipment at the total cost of approximately \$5,000.00. Mayor Perry said it was due to our error and he felt we owed the money to him. The question of filing an insurance claim was brought up and it was determined that it would be more feasible to reimburse him than to file another insurance claim on top of the three recent claims made.
