

Minutes of the Regular Meeting of the Board of Trustees of the Village of Lake George, NY, held on Monday, March 18, 2024 at 4:30 p.m. Zoom teleconferencing was also available.

At 4:30 p.m. Mayor Perry opened the Regular Meeting and asked Trustee Filomeno to lead the Pledge of Allegiance.

Mayor Perry presented the minutes from the Regular Meeting held on February 12, 2024. Trustee Root noted a correction needed to be made on the vote for Resolution 54, 2024 where he had voted Nay. Trustee Root made a motion, seconded by Trustee Miller, unanimously carried to approve the minutes with the correction from the meeting.

Monthly reports from the Sanitation Department and Caldwell Sewer District, Superintendent of Public Works, Planning & Zoning Office, Fire Department, and REC Center, and Special Events were presented and made available to the public.

Mayor Perry presented correspondence submitted by former Mayor Blais, endorsing a requested encroachment onto Village property by property owned by Doug Frost. Mayor Perry asked Doug Frost to please present his request for encroachment. Mr. Frost explained that he had property at 175 Canada Street which has an existing overhang. He said he was looking to build a second story that would be used for short term and long-term rentals and that he would need a license to encroach for the overhang. Mr. Frost added that the current overhang has existed since 1960. He continued that he would like to continue to use the overhang plus add railings. Trustee Root asked if it would be used as a balcony on the second floor. Doug Frost responded that it would be more for aesthetics. Trustee Root asked if it would come out further than it already is, Mr. Frost responded no. Trustee Mastrodomenico asked where tenants would enter the apartments. Mr. Frost responded they would access their apartments from the inside of the lower level. Trustee Miller asked if the purpose of the apartments would be for short- and long-term rentals. Mr. Frost responded that there would be six long-term rentals and three or four short-term rentals.

Whereas, the Aid and Incentives for Municipalities (AIM) program plays a critical role in funding essential municipal services for cities and villages across New York State; and

Whereas, city and village officials share the same priorities as our state leaders which is to make New York safer and more affordable; and

Whereas, New York's local governments, who are on the frontlines of controlling property tax affordability and ensuring public safety, are integral to achieving those goals; and

Whereas, the State has not increased AIM funding in 15 years and according to the Bureau of Labor Statistics, inflation has increased by nearly 45% during that same period; and

Whereas, this neglect from the State has led to rising municipal tax burdens and harmful disinvestment in essential municipal services and staff; and

Whereas, the property tax cap further limits the ability of local governments to properly fund the services their residents need; and

Whereas, the challenges of rising inflation, the increasing costs of labor and supplies, and the end of extraordinary federal aid, only accentuate the need for an increase in AIM funding; and

Whereas, the Governor's 2024-25 Executive Budget proposes to keep AIM funding flat; and

Whereas, an increase in AIM funding would reduce the local tax burden and help revitalize communities across New York;

Now, therefore, be it resolved that the Village of Lake George urges Governor Hochul to work with the leaders of the Senate and Assembly and increase AIM funding in the 2024-25 adopted State Budget.
