The current ticket booth is 10' 3" long (north-south) by 8' 3" deep (east-west). The proposal is to construct an enlarged booth which will be 13' 4" long (north-south) by 13' 1" deep (east – west). It will be approximately 174 square feet. It will be located in the same area. The main part of the building will be grey with white and green trim. Roof will be shingled.

Carol explained that a variance has been granted so that the building can be located 16 feet away from the lake which is its current location. It can be further away from the lake but it cannot be any closer than 16 feet.
