§ 95-1. Regulations for dock use. [Amended 5-19-2003 by L.L. No. 6-2003]

Docks on Lake George owned by the Village shall be used by owners of pleasure boats according to the rules and regulations prescribed by this chapter, to wit:

A. Boats or watercraft used for hire or commercial purposes are prohibited from utilizing the docks for any purpose.

- B. The [following] charges on the fee schedule mentioned in Chapter 100 of the Village Code shall apply to all boats moored at the Village docks at any time of day. [: \$3 per hour, per boat, with a minimum one-hour charge of \$3.]

- C. No boat may be moored for a period longer than 20 consecutive hours. [Amended 3-19-2012 by L.L. No. 2-2012; 9-17-2018 by L.L. No. 9-2018]
- D. Operators of boats moored shall be responsible to display a "pay and display" receipt on the windshield or dashboard of their boat on the dockside of the vessel in clear sight of viewers. Only "pay and display" purchased at the kiosk for boats may be displayed on any boat.

E. No boats or watercraft of any description, except those authorized by the Village Board of Trustees, e.g., police, fire, special event vessels, shall be moored between the hours of 5:00 a.m. and 9:00 a.m. daily.

Each violation of this chapter shall be punishable by a fine documented in the Village fee schedule from Chapter 100 of the Village Code. [fine of not less than \$100 nor more than \$500.]

§ 157-2. License fee.

A license for such purpose may be granted upon the payment of a fee <u>documented in the Village fee schedule from Chapter 100 of the Village Code</u> [of \$10] for each day for which a license to conduct an auction is granted, and [\$5 a day] for each day for which any other license is granted hereunder.

Every violation of the provisions of this article shall constitute disorderly conduct, and the person, violating the same shall be a disorderly person and subject to a penalty specified on the fee schedule in Chapter 100 of the Village Code [of \$100] for each and every violation thereof and, in case of default in payment of such penalty, the defendant shall be committed to the Warren County Jail for a term not exceeding one day for each dollar of the penalty imposed.

Conviction of a second offense, both of which were committed within a period of five years, is punishable by a fine published in the Village fee schedule [of not less than \$500] for each and every day the violation exists, or imprisonment for a period not to exceed six months, or both. Conviction for a third or subsequent offense, all of which were committed within a period of five years, is punishable by a fine published in the Village fee schedule [of not less than \$750] for each and every day the violation exists, or imprisonment for a period not to exceed six months, or both.

B. The term "person" shall include the owner, tenant, occupant, mortgagee or vendee in possession, assignee of rents, receiver, executor, trustee, lessee, sublessee, agent or any other person, firm or corporation directly or indirectly in control of any premises, building or part thereof.

§ 170-5. Penalties for offenses.

A. Every person violating any provisions of this chapter shall be guilty of a violation upon conviction thereof and shall be subject to a fine [not to exceed \$50] published in the Village fee schedule for the first offense, and [not more than \$100] for each offense thereafter.

B. In addition to any other remedies or penalties that may be imposed, a violation of this chapter shall entitle the Board of Trustees to undertake a remedy to repair any damage caused by the violation of any section or provision of this chapter, and the actual disbursements and expenses therefore shall be added to the fine(s) set forth in this chapter. This provision shall be in addition to any other provisions, penalties or powers available to the Village for enforcement of this chapter.

# VILLAGE OF LAKE GEORGE COUNTY OF WARREN, STATE OF NEW YORK Local Law No. 3 of 2025 Chapter 170 Skating, Skateboarding, Coasting and Sliding

Be it enacted by the Board of Trustees of the Village of Lake George ("Village"), County of Warren, State of New York ("State") as follows:

Chapter 170 Skating, Skateboarding, <u>Scooting</u>, Coasting and Sliding

\*\*\*

§170-4. Traffic violations; parental responsibility; police [and peace authority], peace, and code enforcement authority; effect on other provisions.

- A. It is a violation for any person to do any act or fail to perform any act required by this chapter.
- B. The parent of any child and the guardian of any ward shall not authorize or knowingly permit such child or ward to violate any of the provisions of this chapter.
- C. Any police officer, [or] peace officer, or code enforcement officer who issues an appearance ticket and/or other accusatory instrument to any person alleged to be in violation of this chapter shall be authorized to confiscate such play vehicle as evidence pending prosecution hereunder.
- D. If the play vehicle has been confiscated by a peace officer, [er] police officer, or code enforcement officer as set forth herein, the owner thereof may demand a hearing for the return of such play vehicle by making a written application to the court, provided such written application is made within five days of the date such play vehicle is confiscated. The court shall hold such hearing within five business days of the date it receives the request thereof. The court can authorize the retention of the play vehicle if it finds, by a preponderance of the evidence, the following:
  - (1) Probable cause to believe that the person charged with the violation of this chapter was operating such play vehicle in violation thereof; and

(2) The play vehicle confiscated by the police officer or peace officer was the play vehicle used by the accused on the date and time charged.

E. No part of this chapter shall be interpreted to alter, amend or exclude in any way other regulations provided for bicycles in this Code.

# LOCAL LAW NO. 3, 2025 ADOPTED

Mayor Perry asked the audience if anyone had anything they wished to present to the Board. Morgan Taylor said that she had two things she would like to go over. Mayor Perry asked her to come forward and address the Board.

Ms. Taylor said that the first question was regarding parking on Smith Street. She said that there was supposed to be parking only on one side, but that people were double parking all the time. She asked what could be done to enforce the one side only parking. Mayor Perry said that he had spoken with DPW, and they would be re-posting the street for no parking and that they did widen the street for hiking.

Ms. Taylor then asked what could be done to help curb the number of feral cats in the Village. She suggested possibly having the Village look at the feasibility of trapping, spaying and then re-releasing the felines. Mayor Perry said that it was simpler to bring the cats to the shelter that was located at George's but that since the shelter closed it has become more difficult to find no kill shelters to take the cats. Trustee Miller voiced her concern regarding discerning whether a cat was feral or just an outdoor cat. There was discussion back and forth between the Board and Ms. Taylor. The Mayor asked Ms. Taylor to reach out to Northshore to see if there was a program they would suggest and then come back to present it to the Board. Mayor Perry thanked Ms. Taylor for her questions.

Mayor Perry asked Chief Barber if he had anything he would like to present. Chief Barber thanked the Board for the progress on parking for Amherst Street. He said that he had met with Superintendent Lanfear and others regarding the water at the Rec Center and hoped that they could continue exploring the water matter there. Chief Barber then said that he was a little taken aback regarding the whole Budget process and hoped that there could be better warning when the Fire Department was running low in their budget. Clerk Julie Allen reminded Chief Barber that the fiscal report was available at every monthly Board meeting, and she suggested he come into the Village office once a month and ask for a printout of the Fire account.

Mayor Perry asked if there were any other comments or questions from the audience. William Clough said that he would like to thank the Board for working with the Model T Ford Club Tour on their event.
