SIDEWALK CAFÉ - APPLICATION AND PROCESS.

- Patricia Dow pointed out that the requirements for insurance 2M per person, 1M per occurrence appear to be backwards (Editorial note: the amounts have been reversed and will be corrected in the future.)
- All insurance must be purchased and proof provided before the application is approved. Business License renewal will also require proof of insurance in subsequent years.
- Robert Mastrantoni, using Somewhere in Time as an example, because there are center steps, questioned what could be done as a sidewalk café for a building which is restricted by stairs. Could something be extended over the stairs to accommodate 4 tables? Dan Brown mentioned that there may be a problem with reconfiguring the steps, even if temporary, because the American Disabilities Act. The building is currently grandfathered and therefore, handicap access is not required. The Board suggested that the owner research the disability requirements prior to submitting an application.
