The material will be shingles which will match the shingles on the cottages which are north of the main building. The Board discussed stormwater runoff. The peaked roof will be guttered. There is a stormwater drain located right near the current office.

Mohammad explained he would like to remove the stairs on the outside of the office that go to the second floor over the restaurant. If he removes these stairs he would also like to move the handicap ramp closer to the building in the area of the stairs and create a separate entrance for the restaurant.

**MOTION:** Patricia Dow made a motion to approve the installation of a peaked roof on the main motel building which is located on the southern side of the property. The roofing material will be shingles which will match the other roofs on the property. Patty mentioned the sign should be placed above the door on the building which will require trimming the sign to fit in the area above the doorway and underneath the current lighting. The sign should be redesigned to fit in the area and not simply trimmed at the bottom to fit in the area.

As an alternative the Board discussed the option of leaving the sign the current size (25 Sq. Ft.) and moving the lighting up so that the sign fits above the doorway and does not overhang into the space of the doorway. The Board agreed this would be an acceptable alternative.

Liz mentioned the owner may want to install new gooseneck lights which would be the same style and design as the gooseneck lights approved at the July meeting. The Board agreed this would be acceptable.

## **MOTION**: Patty Kirkpatrick made the following motion:

As individuals we each object to the sign change at Peace Love Happiness. However, after looking into the current ordinances and codes and consulting with our Planning Board Attorney, Mark Schachner, and knowing that denying the application would result in costly litigation and further front page exposure for the store and the applicant's platform, we have no choice but to approve this application. Despite our personal objections to promoting this brand, I make the motion to approve the sign with the changes in size as discussed so that the sign is placed 2 to 4 inches above the door trim. As an alternative the existing lights can be removed and the 25 square foot sign with no size adjustment can be installed above the doorway trim with two new gooseneck lights above the new sign. The gooseneck lights will be identical to those approved in July 2012 for the other Dilligaf store.

3. Determine from the presenter's perspective how long this meeting could be. The Board also suggested the date and time be worked with their timeframe. Members from other Boards who may be interested in this topic can make the date and time or read the minutes; it's too difficult to get large groups together.

#### SIGN GUIDELINES

The Board discussed a plan of action for reviewing the sign ordinance. Patty asked about signs and gooseneck lighting that encroach on Village property; she mentioned lighting has been approved that encroaches on Village property. Carol explained to the Board that the Village Board has approved items on the Village sidewalk providing a license to encroach is secured from the Village Attorney. She added that the Village has also allowed licenses to encroach for such items as stairs, porches and buildings which encroach onto Village property and there are several of those licenses which are currently active. Regarding lights and signage on a building Carol mentioned she believed this has just been an oversight but would look into it.

Chuck mentioned the Planning Board should always consider the cost in making a sign; it's difficult to require all wood carved signs, for instance. He added that creating guidelines which will ensure approval creates an atmosphere where all signs look alike and he is not in favor of this. He likes the variety of signs and prefers to approve them separately as this current process allows for creativity and allows each store operator to work within their budget.

Patty spoke about the guidelines that could be developed. The guidelines could include very generic information about the shape, lettering and colors and then perhaps the sign could be approved by Carol and Doug and all other signs would have to be approved by the Board. Carol mentioned that granting the Zoning Office the authority to approve signs would have to be stated in the Village Code. As an alternative Carol suggested developing the guidelines but not amending the Village Code, just yet. Over the next year the Board can continue to review signs just as they have been doing however, they will be able to see which signs are developed within the guidelines and which are not. Then they can decide if they want to recommend changing the Village Code to allow for the Zoning Office to approve certain signs. The Board liked the idea of developing guidelines and seeing how new signs are designed based on the guidelines as they continue to review signs. They suggested the guidelines and the sign application should all be one document so when an individual is filling out the application they can have the guidelines included in the application packet.

The Board agreed to start working on this at the next Board meeting.
