Applicant addressed the board to explain the changes they are making to an already approved site plan for townhomes at 35 Dieskau Street. The buildings will have full basements and a retaining wall in the back which will be stepped, if possible, depending on soil. There will be less stone in the front than previously approved cultured stone on the lower front façade. The entrances will be adjacent to get the most efficient layout in the town homes. There will be storm water mitigation. The buildings will be slightly lower and the driveways will not have as much of a pitch as previously approved. They will be sided in cypress green.

**MOTION:** Dan Wolfield made a motion to approve the change in the property as presented with green cypress siding and stonework on the lower façade with drainage as presented, a center swale in middle allowing for a catch basin as well as north drainage basin which will be moved to the north side of the driveway; rear retaining wall will be stepped, if possible, based on soil conditions; shake shingle detail will be added to the north side of the unit; a fence and landscaping will be added at the property line, the footprint will remain the same as approved on 5/20/15 and the height of the buildings will be lower than previously approved.
