ZONE:

- Mike Phinney started the presentation by providing a brief overview.
  - o Facility will be 14,800 square feet.
  - o The new building will be in compliance with all required codes.
  - The existing building has 6 bays which are outdated in terms of width and height. There will be 8
    new bays that will be 14 feet wide with 16 foot clearance. The existing bays are about 35% smaller
    than the new bays.
  - o In the existing facility the gear racks are spread out on both sides of the garage. Gear will be organized in one spot with an assembly line design.
  - o As required by current safety codes a decontamination room has been added to the facility.
  - o The new facility will have a larger meeting room which should accommodate about 100 people.
  - Public restrooms have been added for use when the meeting room is used.
  - The kitchen is slightly larger.
  - o As required by federal guidelines a fitness room has been added.
  - The waiting room will be smaller.
  - o The control room will be larger and sized for growth.
  - The site has been maximized to 90% coverage which is allowed by current zoning.
  - There will be landscaping on at the rear of the building screening the driveway.
  - o The sign will be updated.
  - Mature maple trees will be preserved.
  - o The backup generator will be screened by building material and a vegetative screen.
  - Natural stone façade will be at the main entry points.
  - o There will be a metal awning across the garage doors to soften the look of the large doors.
  - o The roof will be a light gray metal roof.
  - The overall look will be the old traditional look of a red brick firehouse using a more modern day material. The upper façade of the parapet will have a board and batten look.
  - Landscape buffers will be used.
  - Air conditions and condensers will be located on the rooftop but screened by an angled roof screen.
  - o A grease trap/separator will be installed in the kitchen area.
  - There will be no exterior dumpster.
  - One handicap parking space will be available in the facility's parking area and 3 will be available on the street.
- A stormwater management plan will be submitted.
