Patricia Dow asked if the railing as shown on the plans would be going all the way around the outside of the deck, Mr. Quirk stated it will go all the way around. Robert Mastrantoni asked if the shingles would be the same color as the existing roof, Mr. Quirk stated that yes they would match.
