Minutes of the Special Workshop Meeting of the Board of Trustees of the Village of Lake George, NY, held on Monday, March 3, 2025 at 4:30 p.m. Zoom teleconferencing was also available.

At 4:30 p.m. Mayor Perry opened the Special Meeting and asked Trustee Mastrodomenico to lead the Pledge of Allegiance.

Mayor Perry opened the discussion on the possibility of enacting a 1% Occupancy tax for Hotels and Motels in the Village of Lake George. He proposed that the Trustees reach out to residents as well as Hotel and Motel owners to get their perspective on the tax. He continued explaining that there was not a rush, and that no decision needed to be made immediately. He said that he had spoken with Dave Kenny Jr. and that proposition was not as popular as he thought it would be, so the Mayor wanted to hear more discussion on the matter.

Trustee Mastrodomenico asked Rob McGregor, who was on Zoom, if he would like to weigh in.

Rob McGregor said that he was unsure why there was so much controversy. He said that there was a need to help cover increasing costs for services, and that the only question was how to pay for it. He said the way he saw it was the increase needed to be paid for by either the residents or the tourists. He said that he felt the costs needed to be covered by the tourists visiting the Village. He said that he felt the message needed to be re-worded so that everyone understood the tax would be earmarked for infrastructure, not to go for promoting more tourism. He suggested the Village frame it as an either-or scenario, where either the residents pay, or tourists pay it through their Hotel/Motel stay. He said he did not see it impacting his business.

Laura Kohls said that she felt it would have a larger impact on the larger Hotels and Motels, especially those that are year-round, as it will put them at disadvantage to neighboring communities. She said that she would speak with other businesses and come back to the next meeting to discuss what she had found.

Mayor Perry thanked everyone for their input.

Trustee Filomeno said he felt this was a good start to the conversation.

Mayor Perry said he was waiting for some numbers from Warren County and that information would be forthcoming.

Mayor Perry presented a change order from C.T. Male Associates for the Geotech soil study.

Trustee Root, seconded by Trustee Mastrodomenico, offered the following resolution:

WHEREAS the Village Board has entered into an agreement with C.T. Male Associates, based on the Proposal for Professional Services submitted to the Village on October 17, 2024, for a cost not to exceed \$13,500, for the Geotechnical services assessment; and

WHEREAS, the further studies will be a cone penetration testing with shear wave velocity measurements of 100 feet below existing grades; and

WHEREAS, the additional cost of this testing by C.T. Male Associates resulted in a change order for the additional sum of \$11,000; and

BE IT RESOLVED, the Village Board hereby authorizes the Mayor to sign into professional services/contractual agreement with C.T. Male Associates for change order number one for said services as part of the Shepard Park Amphitheater project, to be paid for by general budget funds from the 2024-2025 budget as needed; and

BE IT FURTHER RESOLVED, that the Village Board authorizes and directs the Village Mayor, Village Clerk, and Village Director of Planning and Zoning to sign such other documents and take such actions as are necessary to effectuate this Resolution.

Trustee Root suggested that the Trustees receive the benefit at the same rate as current full-time employees, with a 20% cost buy in. Trustee Mastrodomenico suggested possibly offering an initial buy in at 50% then after two years offering it at the 20% rate. Mayor Perry instructed the Trustees to think about what they would like to offer and come back to him.

Mayor Perry presented the results of the poll for the MVP Health insurance renewal. He explained that only one employee wanted to switch to a lower premium plan.
