The Applicant addressed the board to seek relief from §220-24 Sign Standards A. General Regulations (7)

No sign or part thereof shall contain or consist of animation, pinwheels, posters, pennants, ribbons, streamers or other similar moving, fluttering or revolving devices. Such devices, as well as strings or light shall not be used for the purposes of advertising or attracting attention when not part of a sign, except as provided.

The Applicant has opened a barber shop at 36 Montcalm Street and is asking for approval of the barber pole outside of the shop mounted on the building. The Applicant addressed the board to talk about his barber shop he has opened, he explained the philosophy of his business and the need for his barber pole which is a long tradition in the barbering industry. Doug Frost explained that the Planning Board had approved the sign but he felt it should come to the Zoning Board because the barber pole is moving and lit and therefore requires relief from the sign ordinance.

- 1. An undesirable change will not be produced in the character of the neighborhood or will not be a detriment to nearby properties because it is a barber pole hanging on the façade of a barber shop.
- 2. The benefit sought by the applicant cannot be achieved by some other method feasible for the applicant because barbershops historically have a barber pole to advertise.

- 4. The proposed variance will not have an adverse effect or impact on the physical or environmental conditions in the neighborhood or district because the property is located in a commercial district and the barber pole will only be lit and revolving when the shop is open and the barber pole has low illumination.
- 5. The alleged difficulty was not self-created.
