Dan Wolfield felt that it should be better defined and felt it was a public safety issue. Jon Lapper suggested that there be stamped black top. Robert Mastrantoni suggested

there be some signs to watch for pedestrians and to impose a 5mph speed limit in the driveway. There will be landscaping along the edge of the driveway. Applicant indicated that the entry will be only one way. For Marriott guests the Canada Street entrance will be most widely used, not the side driveway. The guests that are checking in will be using the porte cochere and parking will be in the parking garage behind the motel. Robert felt that the signage and stamped black top will be sufficient. Dan Wolfield stated that he was disappointed there would not be an actual sidewalk. Applicant explained they are having issues with the DOT and they have not been responsive to the Applicant.

MOTION: Dean Howland made a motion to approve the 3'wide red brick walkway to match the village pavers (stamped asphalt in red) to define a walking area and signage to indicate pedestrians walking/5mph and additional landscaping.
