MUNICIPAL GOVERNMENTS BORDERING LAKE GEORGE RECOGNIZING  
THE 10<sup>TH</sup> ANNIVERSARY OF THE LAKE GEORGE ROAD SALT REDUCTION INITIATIVE  
REGARDING THE REDUCTION OF THE APPLICATION OF ROAD SALT  
FOR WINTER MAINTENANCE AND DE-ICING**

**The purpose of this Memorandum of Understanding (MOU) is to describe an agreement among the municipal governments bordering Lake George recognizing the Lake George Road Salt Reduction Initiative (“LGRSRI”), which is a program to address the levels of chlorides in, and currently entering, Lake George by reducing the**

application of road salt for winter road maintenance and de-icing practices. The LGRSRI is celebrating its 10<sup>th</sup> year and was based on an MOU that municipalities bordering Lake George unanimously adopted in 2015. This MOU is not a binding commitment, but is a statement of the municipalities to recognize the 10<sup>th</sup> anniversary of the LGRSRI and of the intent of the municipalities signing this document to work in good faith, to continue their partnership in the LGRSRI to reduce the levels of road salt application surrounding Lake George in recognition of the following:

- WHEREAS, up to 2015, there had been a steady increase in the basin-wide use of road salt to assist in winter road maintenance and de-icing; and,
- WHEREAS, within the Lake George watershed, there are a total of approximately 680 lane miles of local, county, state and federal roads and the average purchase rates as reported in 2015 totals an estimated 15,000 metric tons of salt per year; and,
- WHEREAS, the average annual municipal purchase rates have decreased nearly 20% over the 10 year period starting in 2016 with the start of the LGRSRI; and,
- WHEREAS, there are numerous studies that date back to the 1970s documenting the significant increases in road salt in the Lake George watershed and in Adirondack lakes resulting from runoff; and,
- WHEREAS, salt levels have tripled in Lake George from 1980 - 2015, and are about thirty times above the natural background characteristic of Adirondack lakes in undeveloped watersheds; and,
- WHEREAS, the above background level concentration in Lake George in 1980 is almost certainly the result of road salt application in the decades prior to 1980; and,
- WHEREAS, there has been a plateau or leveling of chloride levels in Lake George since 2015, which corresponds with the start of the LGRSRI, as measured by The Jefferson Project; and,

WHEREAS, sodium chloride has displaced calcium bicarbonate as the dominant salt in the lake; and,

WHEREAS, increasing concentrations of chlorides in Lake George can alter the composition of the phytoplankton, periphyton and macroinvertebrate communities altering the food web and hence potentially changing the biological productivity of Lake George (based on scientific data); and,

WHEREAS, continued increases in salt loading in the watershed may also affect the physical circulation of the lake by increasing vertical density gradients that are more difficult to mix; and,

WHEREAS, there is a significant correlation between the density of road surfaces in sub-watersheds and the chloride concentrations in streams that has resulted in some of the largest streams in the Lake George Basin to be moderately impacted by chlorides; and,

**WHEREAS, elevated salt concentration in potable water is a health concern to individuals who drink water from Lake George because increased sodium consumption is linked to high blood pressure, but this concern has been reduced due the apparent leveling of sodium levels in Lake George which can be partially attributed to the LGRSRI; and,**

**WHEREAS, elevated salt concentrations in private drinking wells are a health concern as most private drinking wells located downgradient of roads, especially state maintained roads, where road salt is applied exceed sodium guidelines and have high corrosivity levels from high chloride concentrations; and,**

**WHEREAS, corrosive water in individual drinking wells causes damage to interior plumbing infrastructure and may leach lead in older homes posing a risk to human health; and,**

**WHEREAS, road salt application is linked to leaching of calcium and magnesium from soil, which makes Lake George more hospitable for aquatic invasive species colonization; and,**

**WHEREAS, some of the most obvious toxic effects of road salt are observed in roadside vegetation where high concentrations of salt accumulates and persists and damage is observed with the browning of foliage, premature defoliation, suppression of flowers and die back of terminal roots and the erosion problems that occur when vegetation is affected; and,**

**WHEREAS, road salt is responsible for the increased corrosion of road infrastructure and bridges and vehicle fleets and equipment; and,**

**WHEREAS, as detailed in the previous points, the efforts of the Lake George Road Salt Reduction Initiative have stabilized or even reduced salt concentrations in Lake George and based on this and the supporting information, it is necessary that the Lake George Road Salt Reduction Initiative work and program continue to further the improvement of Lake George, its water quality and its communities.**

**NOW, THEREFORE, IT IS HEREBY**

**AGREED that the undersigned Towns, Village and Counties recognize the significant adverse impacts of excessive application of road salt for winter maintenance and de-icing; and it is further**

**AGREED that the undersigned Towns and Village have previously adopted a similar MOU in 2015 agreeing to initiate the Lake George Road Salt Reduction Initiative; and it is further**

**AGREED that the undersigned Towns, Village and Counties intend to continue reduce the salt loading to Lake George through the reduced application of road salt; and it is further**

**AGREED that the undersigned Towns, Village and Counties will curtail the increase of road salt through proven methods of road salt application through utilizing Best Management Practices that are part of the Sustainable Winter Management (SWiM™) Certification program; and it is further**

**AGREED that the undersigned Towns, Village and Counties help to document the effectiveness of said Best Management Practice through data collection; and it is further**

**AGREED that the undersigned Towns, Village and Counties will investigate and consider equipment to better manage and monitor the application of road salt; and it is further**

**AGREED that the undersigned Towns, Village and Counties will have highway department superintendents, collect data using consistent methods on the quantities and application rates of road salts within their jurisdictions, as well as truck loading and route distribution information in using this data for improved application methods and it is further**

**AGREED that the undersigned Towns, Village and Counties will have highway department supervisors assess and tailor road salt application rates based on level of surface, road grades and proximity to water bodies and runoff systems; and it is further**

**AGREED that the undersigned Towns, Village and Counties will participate in an education and training program for all highway department employees on the impacts of road salt to Lake George and proven methods to reduce road salt application; and it is further**

**AGREED that the undersigned Towns, Village and Counties will consider achieving SWiM™ Certification through WIT Advisors which will start through a Discovery evaluation of the current equipment and practices of the specific highway facility and this evaluation will not obligate the municipality from complete commitment to the proven success program; and it is further**

**AGREED that the undersigned Towns, Village and Counties will participate in the annual Adirondack – Champlain Regional Salt Summit” to discuss new technologies, application methods, best management practices and research aimed at minimizing the usage of road salt for winter maintenance and de-icing; and it is further**

**AGREED that the undersigned Towns, Village and Counties support the recommendations of the Adirondack Road Salt Reduction Task Force Assessment and Recommendations for New York State to reduce road salt usage and its impacts for the long-term benefit of the protection of Lake George and it is further**

**AGREED that the undersigned Towns, Village and Counties will together achieve road salt reductions that through ongoing scientific monitoring are shown to benefit the biological, physical, and chemical conditions of Lake George; and it is further**

**AGREED that this Memorandum of Understanding may be signed in counterparts.**

**WHEREAS** while the treatment plant is relatively new, currently this plant does not have the capacity to intake and process the volume of septage that is being brought in by septic haulers due to its lack of a holding pond required for this activity; and

**WHEREAS** THE Village of Lake George recognizes that due to the increased volume of septage created regionally from the Lake George Park Commission's mandatory septic pump-out and inspection program, its treatment plant will need to design and ultimately construct this holding pond, at an estimated cost of approximately 3 million dollars; and

**WHEREAS** to seek appropriate funds for this holding pond construction project a full design of this system needs to be completed; and

**WHEREAS** recognizing this funding challenge and the Park Commission's involvement in this matter, the Village is seeking financial assistance from the Commission to offset some of the cost of this engineering design, as noted through a formal letter from Village Mayor, Ray Perry.

**NOW THEREFORE BE IT RESOLVED** that the Commission, recognizing that its septic pump-out program has been a key factor in the need for this new holding pond, seeks to assist the Village with this improvement through funding assistance in the amount of \$48,000, to be paid upon completion and receipt of an engineered stamped design for this project.

**VILLAGE OF LAKE GEORGE  
COUNTY OF WARREN, STATE OF NEW YORK  
Local Law No. 7 of 2025  
Adopting Chapter 60 "Amusement Products"  
Of the Code of the Village of Lake George**

**BE IT ENACTED** by the Board of Trustees of the Village of Lake George, New York as follows:

\*\*\*

**§60-1. Legislative Intent.**

The Village of Lake George has experienced significant problems with the discharge of noise producing products known as "snaps" "pop-its" fireworks and similar products. Such products have caused reactions and harm to the public as the products release a loud bang sound similar to a gunshot and also leave behind litter due to the paper wrapping around these small products. The Village has received countless complaints from the sounds of these products as well as the litter to municipal property, sidewalks and parks because of their minute pieces which impossible to completely clean up. These effects have been confirmed by members of the public, property owners, and the Village Department of Public Works. It is the intent of the new chapter of the Code of the Village of Lake George adopted in this local law to protect the public's health, safety and welfare.

**§60-2. Definitions.**

As used in this local law, the following terms shall have the meanings indicated:

**PERSON** — Any individual, corporation, not-for-profit corporation, partnership, limited liability company, or any other entity.

**SNAPS** — An amusement product that has a small amount of explosive wrapped in paper or other product that has a "snap" sound when thrown, hit or stepped on, also known as "Throw Snappers," "Pop-Its", "Party Snaps", or similar names or identifying properties.

**§60-3. Restricted sales.**

Effective October 1, 2025, no person, corporation or entity shall sell or offer to sell snaps in the Village of Lake George.

**§60-4. Discharge in public prohibited.**

No person shall discharge snaps in or along any street, sidewalk, park, public parking lot, places of business or other public places in the Village of Lake George.

**§60-5. Penalties for offenses.**

Any person who violates any provision of this local law shall, upon conviction thereof, be guilty of a violation and shall be subject to a fine not to exceed \$250 or imprisonment for a term not to exceed 15 days, or both. Each instance of violation of this local law shall be considered a separate violation.

**§60-6. Codification, Numbering.**

The section numbers, chapter number, references to this local law as a chapter of code, and structure of this local law may be renumbered, realigned and codified as part of inclusion in the Code of the Village of Lake George. No such renumbering, realignment or codification shall be deemed to impair the legality of the content of this local law.

**§60-7. Severability.**

If any clause, sentence, paragraph, subdivision, section, or part of this local law or the application thereof to any person, individual, corporation, firm, partnership, entity, or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section, or part of this local law, or in its application to the person, individual, corporation, firm, partnership, entity, or circumstance directly involved in the controversy in which such order or judgment shall be rendered.

**§60-8. Effective Date.**

This local law shall take effect upon filing with the New York State Secretary of State.
