

Minutes of the Regular Meeting and Public Hearings of the Board of Trustees of the Village of Lake George, NY, held on Monday, March 20, 2023 at 4:30 p.m. Zoom teleconferencing was also available.

At 4:30 p.m. Mayor Blais opened the Regular Meeting and asked Trustee Perry to lead the Pledge of Allegiance.

At 4:31 p.m. Mayor Blais continued and opened two Public Hearings to run concurrently:

- Continue Public Hearing for Proposed Local Law No. 1, 2023 for Chapter 118. Food, Drink and Retail Establishment, Article IV Obstruction off Store Windows
- Open Public Hearing for Proposed Local Law No. 3, 2023 for Chapter 195. Article VI Partial Real Property Tax Exemptions for Persons with Disabilities and Limited Income.

Mayor Blais explained that Local Law 1 pertained to the amount of covering a business window can have in the Village. The Village Board is seeking to limit the amount of covering to fifty percent.

Mayor Blais then went on to explain that Local Law 3 is looking to allow people with disabilities and an income under \$32.5K, a partial tax exemption. Mayor Blais said that there would be a requirement of proof in the form of a doctors note and an income statement in order to be eligible.

Mayor Blais asked if anyone had any questions or comments to which there was no response.

Mayor Blais presented the minutes from the Joint Meeting held on February 7, 2023, the Regular Meeting and Public Hearing held on February 13, 2023, and the Special Budget Workshop held March 7, 2023. Trustee Root made a motion, seconded by Trustee Earl, unanimously carried to approve the minutes from all three meetings.

Monthly reports from the Sanitation Department and Caldwell Sewer District, Superintendent of Public Works, Planning & Zoning Office, Fire Department, and REC Center were presented and made available to the public.

Mayor Blais read an email from Patty Kirkpatrick backing the proposed Local Law 1, stating that not only would it help with aesthetics, but with safety.

Mayor Blais then read a thank you letter from Joann Stafford-Paige, and Joseph Paige. Mayor Blais read that the letter wanted to acknowledge Keith Lanfear and the superb job the DPW did this winter with snow removal.

Mayor Blais presented the resolution required for the authorization and serial bond for the purchase of the new Fire Truck. Mayor Blais went on to explain that the Town and Village had agreed to purchase a new ladder truck for the Fire Department, subject to permissive referendum.

Trustee Earl, seconded by Trustee Mastrodomenico, offered the following resolution:

RESOLUTION NO. 252, 2023

A RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) ROSENBAUER AERIAL FIRETRUCK, COMPLETE WITH ROSENBAUER COMMANDER CHASSIS AND ROSENBAUER COBRA PLATFORM AT A MAXIMUM COST OF \$1,670,734 AND THE ISSUANCE OF \$1,200,000 SERIAL BONDS OF THE VILLAGE OF LAKE GEORGE, WARREN COUNTY, NEW YORK.

WHEREAS, on March 20, 2023 the Board of Trustees of the Village Board of the Village of Lake George desires to purchase one (1) Rosenbauer Aerial Firetruck, complete with Rosenbauer Commander Chassis and Rosenbauer Cobra Platform at a maximum cost of \$1,670,734, of which \$1,200,000 to be obtained from the proceeds of the obligations issued pursuant to the Local Finance Law, and the balance of up to \$470,734 to be paid from Village funds.

NOW, THEREFORE, BE IT RESOLVED:

1. The Village Board of the Village of Lake George, Warren County, New York, hereby authorizes the purchase of one (1) Rosenbauer Aerial Firetruck, complete with Rosenbauer Commander Chassis and Rosenbauer Cobra Platform at a cost not to exceed \$1,670,734.
2. The specific object or purpose for which obligations are to be issued pursuant to the resolution is the purchase of one (1) Rosenbauer Aerial Firetruck, complete with Rosenbauer Commander Chassis and Rosenbauer Cobra Platform.
3. The current maximum cost of the aforesaid specific object or purpose of this resolution is \$1,670,734, and the plan for the financing thereof is the issuance of \$1,200,000 serial bonds of said Village hereby authorized to be issued pursuant to the Local Finance Law, and the payment of \$470,734, or so much thereof as may be necessary, from funds of the Village. Such bonds are to be payable from amounts which shall annually be levied on all the taxable real property in said Village, and the faith and credit of said Village of Lake George, Warren County, New York, are hereby pledged for the payment of said bonds and the interest thereon.
4. It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose of this resolution is twenty (20) years, pursuant to subdivision 27 of Paragraph a of Section 11.00 of the Local Finance Law.
5. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell serial bonds and bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Mayor of the Village of Lake George, the chief fiscal officer, or in his absence, the Village Clerk, who is the substituted chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be determined by said Village Mayor or Village Clerk pursuant to and consistent with the provisions of the Local Finance Law.
6. This resolution is adopted subject to a permissive referendum pursuant to Section 36 of the Local Finance Law and Article 9 of the Village Law of the State of New York.
7. The validity of such bonds and bond anticipation notes may be contested only if:

a. Such obligations are authorized for an object or purpose for which said Board of Trustees is not authorized to spend money; or

b. The provisions of law which should be complied with as of the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or

c. Such obligations are authorized in violation of the provisions of the Constitution.

8. This notice and resolution shall be published in full within ten (10) days after its adoption in the Post Star, which is hereby designated as the official newspaper of the Village for such purpose. This resolution shall take effect thirty (30) days after its adoption and thereafter shall be published in full in The Post Star, together with a notice of the Village Clerk substantially in the form provided in Section 81.00 of the Local Finance Law.

Mayor Blais presented the request from Jose Filomeno to approve the deck enclosure in relation to the proposed modification to the existing structure's easement on the Village property. Mayor Blais asked Jose Filomeno to explain what he is looking to do. Jose Filomeno explained that there is a small portion of his building that is on Village Property that he would like to make improvements to. Jose Filomeno then further explained that he is looking to enclose his deck and winterize it to run his business year-round. Mayor Blais said that he sees no issue to approve this request. Trustee Mastrodomenico said that the property is already being used and they are not requesting more so he saw no issue as well.

Trustee Mastrodomenico, seconded by Trustee Root, offered the following resolution:

Mayor Blais then reviewed a few local law amendments that the Village should consider. Mayor Blais presented Chapter 174, Snow Removal and Emergency Conditions to the Board where it would be unlawful for anyone to place snow in the public right of way from private property. Mayor Blais then presented an amendment to Zoning Law, Chapter 220, where it would allow condominiums along the lake front walkway. Mayor Blais last read another Zoning Law, Chapter 220, Outdoor Bars, where it would prohibit outdoor bars, unless they are permanent structures (except for grandfathered such as "ice bars").

Mayor Blais then asked Clerk Julie Allen to go over the resolutions to be considered.

Clerk Allen reviewed the list of resolutions to be considered by the Village Board.

Mayor Blais then asked if any of the Trustees had questions or issues with any of the resolutions. Trustee Root responded that he wanted to discuss the creation of the Director of Special Events position, as well as the IMA with Warren County. Trustee Root then questioned Clerk Julie Allen as to whether we received any applications for the Director of Special Events. Clerk Julie Allen responded yes, three, which have been given to Trustee Perry. Trustee Perry then said he would be conducting interviews with the three candidates over the next week. Trustee Root then suggested that the Board table the creation of the position until after the interviews were conducted, being that it was very close to an election and there would be two new Trustees that he felt should participate. Trustee Perry responded that if we do not create the position now, we cannot include it in the Budget or the annual meeting. Trustee Root said he understood, but he was not totally in line with the description of the position as there was conflicting information. Trustee Perry said he only saw one job description. Trustee Root responded that there was a draft job description by the County, then the description of the duties in the IMA didn't totally align. Trustee Perry then explained that the IMA is only a part of the entire job as the IMA only covers Wood Park, and there is a lot more than that in the total description. Trustee Root then suggested that the position be one of co-creators, where if Mayor Blais held one of the positions, he would be able to train the other for when he leaves. Trustee Perry then said this is the first time he is hearing of this idea and Trustee Root responded that they had not had the opportunity to speak of it at any length. Trustee Mastrodomenico then asked Trustee Root if he was looking to have two people do this position. Trustee Root explained that he would like to see two co-creators, so that when the Mayor decides to step down, then there would be somebody in place to take over. Trustee Root further explained that the salary would also need to be split in an equitable way. Trustee Perry responded that the County was looking for something completely different than what Trustee Root was suggesting. Trustee Perry felt it would be best if we continued with that the County asked for. Trustee Perry then said if we wanted to, we could create the position and then modify it later if that is what was decided. Trustee Root said that we could put it up for a vote and go from there, but it could be more work in the long run.

Trustee Perry, seconded by Trustee Earl, offered the following resolution:

WHEREAS, it is has become necessary due to workload, to create a new position to cover the needs of the Village regarding Event Planning and Administration;

BE IT RESOLVED, that the Board of Trustees approves the creation of the position of Director of Special Events. The position created is appointed, part time, and the salary to be based on experience. This position is to begin April 1, 2023, and will re-appoint annually.

Mayor Blais then asked Operator Shudt to explain the additional \$2.5M that was needed. Operator Shudt explained that the additional \$2.5M would be used to make the wet well side explosion proof as required. Mayor Blais then explained that this means the Village needs to come up with a total of \$5M

to get the WWTP fully compliant and efficient. Mayor Blais further explained that the Village would need funding to accomplish this, and that the way to do this was to apply for grants. Mayor Blais explained they had spoken with consultant Jim Thatcher of CT Male to get help to apply for the grants. CT Male proposed that they would complete our applications for the grants for the amounts of \$7.5K total.

Trustee Perry, seconded by Trustee Mastrodomenico, offered the following resolution:

WHEREAS, there is a need for upgrades on the receiving capacity and wet well at the Wastewater treatment facility; and

Mayor Blais explained that the mural in the Board Room had not been updated in 15 years and is looking to have anywhere from eight to ten new people added. Mayor Blais went on to say the Mural is used to honor those who have contributed to the community. Mayor Blais said he found a local University artist that is willing to do the work this summer. Mayor Blais read the list of suggested individuals that the Board may want to consider and asked them to look at it and make suggestions for anyone he may have missed. Superintendent Lanfear explained that they had determined that only a ten-foot portion of the culvert needs to be replaced and that due to the time of the year he wants to get working on replacing it now. Superintendent Lanfear feels that it would best to get the work completed before there is a large increase in foot traffic and the workload increases.

Trustee Earl, seconded by Trustee Root, offered the following resolution,

WHEREAS, a large culvert known as “Prospect Brook” culvert has deteriorated; and

WHEREAS, such culvert is in the parking area of Shoreline Cruise, 2 Kurosaka Lane; and

WHEREAS, this culvert carries a considerable amount of stormwater into Lake George and is creating sink holes on subject's property; and

WHEREAS, this parking lot is necessary to the business's operation during summer season,

BE IT RESOLVED that we, the Village Board of Trustees of the Village of Lake George do hereby declare this project an emergency to allow our equipment and personnel to repair said current prior to our busy spring and summer season.

Mayor Blais presented an email he received regarding the new Lake Champlain Watershed Implementation Plan. Mayor Blais said that they are taking public comments and that if anyone would like to comment the email was waterlog@dec.ny.gov.

At 5:30 p.m. Mayor Blais returned to the two Public Hearings and asked the Boards pleasure for Proposed Local Law 1, Chapter 118, Article IV, Obstruction of Store Windows.

Trustee Perry made a motion, seconded by Trustee Root, to table Local Law 1.

Trustee Earl asked the reason for tabling and Trustee Perry responded to review the streets as it only mentions Canada Street and possibly adjusting the percentage of the window coverage. Mayor Blais said there was some controversy because there was a newspaper article that the Mayor did not participate in where is mentioned a specific business. Mayor Blais said the Local Law was not meant for one specific business, but for all, as full coverage on a window is a safety hazard and to improve the aesthetics of the Village. Mayor Blais told of a time many years ago as a police officer he was able to catch a fire in its early stages because he was able to see it through the window from the street.

Mayor Blais said there was a motion to table, and he asked each Trustee and himself, their vote, all voted Aye.

Local Law No. 3 of 2023
CHAPTER 195 ARTICLE VI
PARTIAL REAL PROPERTY TAX EXEMPTIONS FOR PERSONS WITH DISABILITIES AND
LIMITED INCOMES**

Be it enacted by the Board of Trustees of the Village of Lake George ("Village"), County of Warren, State of New York ("State") as follows:

Section 1. Article VI Partial Real Property Tax Exemptions For Persons With Disabilities And Limited Incomes.

There shall be enacted a new Article VI of Chapter 195 of the Code of the Village of Lake George, titled "Partial Real Property Tax Exemptions For Persons With Disabilities And Limited Incomes" as follows:

§ 195-28. Legislative Intent.

It is the intention of the Board of Trustees of the Village to enact a partial exemption from real property taxes pursuant to Real Property Law §459-c.

§ 195-29. Definitions.

For purposes of this Local Law, the following shall be defined as follows:

- a. "Sibling" shall mean a brother or a sister, whether related through half blood, whole blood or adoption.
- b. "Person with a Disability" is one who has a physical or mental impairment, not due to current use of alcohol or illegal drug use, which substantially limits such person's ability to engage in one or more major life activities, such as caring for one's self, performing manual tasks, walking, seeing, hearing, speaking, breathing, learning, working, and who:
 - i. is certified to receive social security disability insurance (SSDI) or supplemental security income (SSI) benefits under the federal Social Security Act; or
 - ii. is certified to receive Railroad Retirement Disability benefits under the federal Railroad Retirement Act; or
 - iii. has received a certificate from the state commission for the blind and visually handicapped stating that such person is legally blind; or

iv. is certified to receive a United States Postal Service disability pension.

An award letter from the Social Security Administration or the Railroad Retirement Board a certificate from the state commission for the blind and visually handicapped or an award letter from the United States Postal Service shall be submitted as proof of disability.

§ 195-30. Partial Exemption for Persons with Disabilities and Limited Incomes.

a. Pursuant to the provisions of Section 459-c of the Real Property Tax Law, real property located in the Village which is owned by one or more persons with disabilities, or real property owned by a husband, wife or both, or by siblings, at least one of whom has a disability, and whose income as hereafter defined, is limited by reason of such disability, shall be exempt from taxation by the Village to the extent provided in the following schedule:

<u>Annual Income</u>	<u>Percentage of Assessed Valuation Exempt from Taxation</u>
<u>\$0 to \$23,000</u>	<u>50%</u>
<u>\$23,001 to \$24,000</u>	<u>45%</u>
<u>\$24,001 to \$25,000</u>	<u>40%</u>
<u>\$25,001 to \$26,000</u>	<u>35%</u>
<u>\$26,001 to \$26,900</u>	<u>30%</u>
<u>\$26,901 to \$27,800</u>	<u>25%</u>
<u>\$28,801 to \$29,700</u>	<u>20%</u>
<u>\$29,701 to \$30,600</u>	<u>15%</u>
<u>\$30,601 to \$31,500</u>	<u>10%</u>
<u>\$31,501 to \$32,400</u>	<u>5%</u>

b. Exemption from taxation for school purposes shall not be granted in the case of real property where a child resides if such child attends a public school of elementary or secondary education.

§ 195-31. Effect of Other Exemptions Authorized By Law.

Any exemption provided by this Local Law shall be computed after all other partial exemption allowed by law; excluding the school tax relief (STAR) exemption authorized by Section 425 of the Real Property Tax Law, have been subtracted from the total amount assessed; provided, however, that no parcel may receive an exemption for the same municipal tax purpose pursuant to both this Local Law and Section 467 of the Real Property Tax Law.

§ 195-32. Exclusions.

a. No exemption shall be granted:

i. if the income of the owner or the combined income of the owners of the real property for the income tax year immediately preceding the date of making application for exemption exceeds the sums provided for in this Local Law. Income tax year shall mean the twelve month period, for which the owner or owners filed a federal personal income tax return, or, if no such return is filed, the calendar year. Where the title is vested in either the husband or wife, their combined income may not exceed such sum, except where the husband or wife or ex-husband or ex-wife is absent from the property due to divorce, legal separation or abandonment, then only the income of the spouse or ex-spouse residing on the property shall be considered and may not exceed such sum. Such income shall include social security and retirement benefits, interest, dividends, total gain from the sale or exchange of a capital asset which may be offset by a loss from the sale or exchange in the same income tax year, net rental income, salary or earnings, and net income from self-employment, but shall not include a return of capital, gifts inheritances or monies earned through employment in the federal foster grandparent program. In computing net rental income and net income from self-employment no depreciation deduction shall be allowed for the exhaustion, wear and tear of real or personal property held for the production of income.

ii. unless the real property is used exclusively for residential purposes, provided, however, that in the event any portion of such property not so used exclusively for residential purposes but is used for other purposes, such portion shall be subject to taxation and the remaining portion only shall be entitled to the exemption provided by this Local Law.

iii. unless the real property is the legal residence of and is occupied in whole or in part by the disabled person; except where the disabled person is absent from the residence while receiving health-related care as an inpatient of a residential health care facility, as defined in Section 2801 of the Public Health Law, provided that any income accruing to that person shall be considered income for purposes of this Local Law only to the extent that it exceeds the amount paid by such person or spouse or sibling of such person for care in the facility.

§ 195-33. Application Process.

a. Application for such exemption must be made annually by the owner, or all of the owners of the property, on forms prescribed by the state board, and shall be filed in the Town of Lake George Assessor's office on or before the appropriate taxable status date; provided, however, proof of a permanent disability need be submitted only in the year exemption pursuant to this Local Law is first sought or the disability is first determined to be permanent.

b. At least sixty (60) days prior to the appropriate taxable status date, the Town of Lake George Assessor shall mail to each person who was granted exemption pursuant to this Local Law on the latest completed assessment roll an application form and a notice that such application must be filed on or before taxable status date and be approved in order for the exemption to continue to be granted. Failure to mail such application form or the failure of such person to receive the same shall not prevent the

levy, collection and enforcement of the payment of the property owned by such person.

§ 195-34. Property Held in Trust.

Notwithstanding any other provision of law to the contrary, the provisions of this Local Law shall apply to real property held in trust solely for the benefit of a person or persons who would otherwise be eligible for a real property tax exemption, pursuant to this Local Law, were such person or persons the owner or owners of such real property.

§ 195-35. Applicability.

This Local Law shall apply to assessment rolls on the basis of taxable status dates occurring on or after January 1, 2023 and each year thereafter.

Section 2. Severability.

If any clause, sentence, paragraph, subdivision, section, or part of this Local Law or the application thereof to any person, individual, corporation, firm, partnership, entity, or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section, or part of this Local Law, or in its application to the person, individual, corporation, firm, partnership, entity, or circumstance directly involved in the controversy in which such order or judgment shall be rendered.

Section 3. Effective Date.

This Local Law shall take effect immediately upon filing with the New York State Secretary of State.

Cathy Flack thanked Mayor Blais.
