

Minutes of the Special Meeting of the Board of Trustees of the Village of Lake George, NY, held on Thursday July 27, 2023, at 4:00 p.m. at the Village Office. The Zoom connection was publicized on the Village's website, listed on the agenda, but unavailable for connection that would allow public participation. Members of the Village Board physically attended at the Village Hall.

Mayor Perry opened the Special Meeting at 4:05 p.m.

Mayor Perry stated that he thinks that the Board should review Resolution 88, 2023 which was passed by the Village Board on July 17, 2023. At that time in which the Village Board passed the resolution they were unaware of some Department of Transportation laws and rules that apply to Canada Street

Mayor Perry explained the guidelines in detail regarding parking and asked if the Village Board wanted to rescind the July 17, 2023, Resolution 88, 2023.

#### **RESOLUTION NO 111, 2023**

**WHEREAS** the Village of Lake George hosts the Adirondack Nationals Car Show annually, and it is scheduled for September 7-10, 2023; and

**WHEREAS** seasonal attendees and owners wish to park their vehicles for extended periods of time, overnight and for numerous days on our public streets, and

**WHEREAS**, these vehicles occupy paid metered spaces,

**BE IT RESOLVED** that the Village Board of Trustees of the Village of Lake George does hereby agree to issue Parking Permits "PP's" set at the following fees:

- Passenger vehicles only \$150. each
- Trailers will not be permitted on Canada Street.

- Trailers or any other vehicles using more than one parking space \$500.
- Trailers can be parked at the REC Center for \$25. each.

**BE IT FURTHER RESOLVED** that the PP's will be valid Tuesday September 5-10, 2023, only.
